Findings:

General: Based on observation and review of documentation, a caregiver hired on 3/15/18, had no documentation of a high school diploma, only a letter of recognition of academic achievement on file. Also, a caregiver hired on 7/10/18, had no documentation of education on file.

395 - TB Verification Not In Compliance

922 KAR 2:090. Section 11. Staff Requirements.

- (1) Child-care center staff:
- (b) Shall provide, prior to employment and every two (2) years thereafter:
- 1. A statement from a health professional that the individual is free of active tuberculosis; or
- 2. A copy of negative tuberculin results.

Findings:

General: Based on review of documentation, a caregiver hired on 7/10/18, did not have a TB documentation on file.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;

Findings:

General: Based on observation and review of documentation, review of documentation, a director hired on 12/12/17, lacked nine (9) hours of training. A caregiver hired on 12/12/17, lacked seven (7) hours of training, completed the Pediatric Abusive Head Trauma Training on 3/15/19, which was not within the first year of employment, and completed the orientation training on 3/13/19 which was not within the first three months of employment. A caregiver hired on 12/12/17, completed the Pediatric Abusive Head Trauma Training and orientation training on 3/15/19, and lacked nine (9) hours of training. A caregiver hired on 3/15/18, lacked seven and a half (7 1/2) hours of training. A caregiver hired on 2/13/18, lacked eight (8) hours of training and completed the Pediatric Abusive Head Trauma Training and orientation training on 3/15/19. A caregiver hired on 7/10/18, had no orientation training. A substitute hired on 12/12/17, lacked nine (9) hours of training and had not completed the Pediatric Abusive Head Trauma Training.

- 1. A first aid supply and is maintained in accordance with subsection (1) of this section;
- 2. Diaper cream, sunscreen, or toothpaste. Diaper cream, sunscreen, or toothpaste shall be inaccessible to a child;
- 3. An epinephrine auto-injector. A licensed child-care center shall comply with KRS 199.8951 and 311.646, including:
- a. An epinephrine auto-injector shall be inaccessible to a child;
- b. A child-care center shall have at least one (1) person onsite who has received training on the administration of an epinephrine auto-injector if the child-care center maintains an epinephrine auto-injector;
 - c. A child-care center shall seek emergency medical care for a child if an auto-injector is administered to the child; and
- d. A child-care center shall report to the child's parent and the cabinet in accordance with 922 KAR 2:090, Section 12(1)(b) if an epinephrine auto-injector is administered to a child; or
- 4. An emergency or rescue medication for a child in care, such as medication to respond to diabetic or asthmatic condition, as prescribed by the child's physician. Emergency or rescue medication shall be inaccessible to a child in care;
- (b) Kept in the original bottle; and
- (c) Properly labeled.
- (7) Medication shall not be given to a child if the medication's expiration date has passed.

Findings:

General: Based on observation, a bottle of Dollar General Store Ibuprofen was not labeled to indicate for whom it was intended. This medication was placed on a shelf, in a storage room, in the nursery.

Outdoor Play Area Not In Compliance

922 KAR 2:120. Section 4. Premises Requirements.

- (20) An outdoor play area shall be:
- (d) Safe from foreseeable hazard;
- (e) Well drained;
- (f) Well maintained;
- (g) In good repair; and

Findings:

General: Based on observation, a four (4) foot long area of weed block was above the mulch on the outdoor play area.

General: Based on observation, the Plexiglas had white spots and smudges on three (3) cribs in the nursery.

Findings:

General: Based on observation, the inside walls of a microwave had dried food splatters and dark marks. Also, the bottom inside wall of an oven was black and sooty. The microwave and oven were located in the kitchen.



1050 - Bottles Not In Compliance

922 KAR 2:120. Section 8. Kitchen Requirements.

- (9) Bottles shall be:
- (a) Individually labeled;
- (b) Promptly refrigerated;
- (c) Covered while not in use; and
- (d) Consumed within one (1) hour of being heated or removed from the refrigerator.

Findings:

General: Based on observation, two (2) bottles were each filled with milk and not covered in the nursery.

- (1) A child-care center shall maintain:
- (a) A current immunization certificate for each child in care within thirty (30) days of the child's enrollment, unless an attending physician or the child's parent objects to the immunization of the child pursuant to KRS 214.036;

Findings

General: Based on review of documentation, a child enrolled on 8/31/18, had an immunization certificate valid until 11/6/18; a child enrolled on 1/12/19, had an immunization certificate valid until 2/27/19; a child enrolled on 4/11/18, had no validity date on the immunization certificate, and a child enrolled on 11/22/18, had an immunization certificate valid until 8/20/18

1140 - Enrollment Information Not In Compliance

922 KAR 2:090. Section 9. Records.

- (1) A child-care center shall maintain:
- (b) A written record for each child:
- 1. Completed and signed by the child's parent;
- 2. Retained on file on the first day the child attends the child-care center; and
- 3. To contain:
- a. Identifying information about the child, which includes, at a minimum, the child's name, address, and date of birth;
- b. Contact information to enable a person in charge to contact the child's:
- (i) Parent at the parent's home or place of employment;
- (ii) Family physician; and
- (iii) Preferred hospital;
- c. The name of each person who is designated in writing to pick-up the child;
- d. The child's general health status and medical history including, if applicable:
- i) Allergies
- (ii) Restriction on the child's participation in activities with specific instructions from the child's parent or health professional; and
- (iii) Permission from the parent for third-party professional services in the child-care center;
- e. The name and phone number of each person to be contacted in an emergency involving or impacting the child;
- f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;

Findings:

General: Based on review of documentation, a child enrolled on 8/13/18, did not include the child's health status and medical history on the enrollment form. Also, a child enrolled on 11/22/18, did not include a preferred hospital, the name of a physician, and the physician's contact information on the enrollment form.

General: Based on observation and review of documentation, twenty-seven (27) children were present at the center; however, only twenty-one (21) children had a documented arrival time.

General: Based on review of documentation, two (2) caregivers hired on 3/15/18 and 2/13/18, did not have a professional development plan on file.

- (b) Each statement of deficiency and civil penalty notice issued by the cabinet during the current licensure year;
- (c) Each plan of correction submitted by the child-care center to the cabinet during the current licensure year;
- (d) Information on the Kentucky Consumer Product Safety Program and the program's Website as specified in KRS 199.897;
- (e) A description of services provided by the child-care center, including:
- 1. Current rates for child care; and
- 2. Each service charged separately and in addition to the basic rate for child care;
- (f) Minimum staff-to-child ratios and group size established in 922 KAR 2:120; and
- (g) Daily planned program.

Findings:

General: Based on observation, the center did not have posted a civil penalty notice issued by the cabinet during the current licensure year. The civil penalty notice was issued on 6/27/18.

1215 - Daily Activities Not In Compliance

922 KAR 2:090. Section 10. Director Requirements and Responsibilities.

- (1) A director shall:
- (h) Post a schedule of daily activities, to include dates and times of activities to be conducted with the children in each classroom;

Findings:

General: Based on observation, there was no date on the posted schedule of daily activities in the two-year-olds' room; the posted schedule of daily activities was dated 2017 - 2018 in the nursery, and the posted schedule of daily activities was dated December 2017 - December 2018 in one-year-olds' room. Also, the posted schedule of daily activities did not include breakfast and the time it was to be served in the one-year-olds' room.

1220 - Diapering/Handwashing Not In Compliance

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

(9) The proper methods of diapering and hand-washing shall be posted at each diaper changing area.

Findings:

General: Based on observation, the proper methods of diapering and hand-washing was not posted at a diaper changing area in the two-year-olds' room.
