#### Findings:

General: Based on observation, the surveyor found the following:

- 1. The third sink in the girls' restroom located in the gym was covered with a black plastic bag; therefore, the sink was not kept in good repair. The sink was not in working order. During interview, staff-in-charge stated that she was unsure if a work order had been put in to fix the sink.
- 2. The second sink in the boys' restroom located in the gym was observed to have no hot or cold running water; therefore, the sink was not kept in good repair. The sink was not in working order. During interview, staff-in-charge stated that she was not aware that the sink was not in working order.
- 3. There was toilet paper and paper towels scattered on the floor of the boys' restroom located in the gym; therefore, the restroom was not kept clean.
- 4. There was toilet paper scattered on the floor of the girls' restroom located in the gym; therefore, the restroom was not kept clean.
- 5. There was toilet paper and paper towels scattered on the floor of the boys' restroom located near the exit to the playground; therefore, the restroom was not kept clean.
- 6. There was toilet paper on the floor of the second stall of the girls' restroom located near the exit to the playground; therefore, the restroom was not kept clean.

- 3. The toilet bowl contained stains in the girls' restroom located near the cafeteria; therefore, the toilet was not kept in clean condition.
- 4. The toilet seat moved easily and was not tightly secured to the toilet in the first stall of the boys' restroom located near the cafeteria; therefore, the toilet was not kept in good repair.
