- 2) There were numerous areas of chipping paint on the walls throughout the facility.
- 3) There were several carpet squares that have come unglued throughout the facility.
- 4) There was a large hole in the wall near the baseboard in the preschool classroom.
- 5) There was a square on the linoleum floor in the preschool classroom made from duct tape. The duct tape was torn and there was a great deal of dirt and debris surrounding the duct tape.
