General: Based on observation and review of documentation, this regulatory requirement was not met. The facility did not have a current copy of the regulations on site for the staff to review

- (1) A director shall:
- (j) Assess each staff person's interaction with children in care and classroom performance through an annual written performance evaluation;

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. One staff member did not have a current staff evaluation on file. This staff member has been employed for more than a year.

- (1) A child-care center shall maintain:
- (e) A current personnel file for each child-care center staff person to include:
- 1. Name, address, date of birth, and date of employment;
- 2. Proof of educational qualifications;
- 3. Record of annual performance evaluation;
- 4. Documentation of compliance with tuberculosis screening in accordance with Section 11(1)(b) of this administrative regulation; and
- 5. The results of background checks conducted in accordance with 922 KAR 2:280;

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. Three staff files did not have documented hire dates. The staff in charge verbally gave the surveyor the staff hire dates.

435 - Training Not In Compliance

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation completed within the first three (3) months of employment in a child-care program;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training completed between July 1 and the following June 30 of each subsequent year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.
- (17) A staff person's compliance with training requirements of this section shall be verified through the cabinet-designated database maintained pursuant to 922 KAR 2:240.

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. The following was found:

- 1. A substitute staff member hired on 8/17/2020, did not complete fifteen hours of cabinet approved early care and education training hours between 7/01/2020 and 6/30/2021.
- 2. A staff member hired on 6/01/2021, did not complete the required Orientation. This staff member has been employed for more than three months.

A review of ECE-TRIS was completed and confirmed these findings.

General: Based on observation, this regulatory requirement was not met. An overhead florescent light was not working in the one-and two-year-old room.

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Based on observation, this regulatory requirement was not met. A hole was observed in the drywall in the diaper changing room where a cable box had been located. A small cable wire was exposed in the box.

922 KAR 2:120. Section 13. Toys and Furnishings.

- (2) Indoor and outdoor equipment shall:
- (a) Be clean, safe, and in good repair;
- (b) Meet the physical, developmental needs, and interests of children of different age groups;
- (c) Be free from sharp points or corners, splinters, protruding nails or bolts, loose or rusty parts, hazardous small parts, lead-based paint, poisonous material, and flaking or chalking paint; and
- (d) Be designed to guard against entrapment or situations that may cause strangulation.

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. The following was found:

- 1. The hand washing sink in the diapering room contained an area of crumbling grout, which caused a gap where the sink was separating from the wall.
- 2. The preschool room contained an alphabet/animals round rug that was stained in several areas.
- 3. A smoke detector was beeping in the diaper changing room. This usually indicates a low battery or a malfunction of the device.

- (a) Breast milk or iron-fortified formula for a child:
- 1. Age birth to twelve (12) months: or
- 2. Beyond twelve (12) months of age as documented by the parent or the child's physician;
- (b) Pasteurized unflavored whole milk for children ages twelve (12) months to twenty-four (24) months; or
- (c) Pasteurized unflavored low fat one (1) percent or fat-free skim milk for children ages twenty-four (24) months to school-age.

Findings:

General: Based on observation, this regulatory requirement was not met. Three children were served the lunches that they packed from home. One child was served Propel Water, one child was served chocolate milk, and another child was served Yoo-hoo milk. One child was one-year-old and the other two children were two-years-old. The one-year-old should have been served unflavored, whole milk, and the other two children should have served unflavored, low-fat, one percent milk, or unflavored, fat-free, skim milk with their lunches.

- (iii) Preferred hospital;
- c. The name of each person who is designated in writing to pick-up the child;
- d. The child's general health status and medical history including, if applicable:
- (i) Allergies
- (ii) Restriction on the child's participation in activities with specific instructions from the child's parent or health professional; and
- (iii) Permission from the parent for third-party professional services in the child-care center;
- e. The name and phone number of each person to be contacted in an emergency involving or impacting the child;
- f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. None of the ten children's files reviewed contained the physician's contact phone number. This information was not on the children's enrollment forms.
