Implementation and Enforcement.</p> <p>(1) A person who is a child care staff member prior to January 1, 2018, shall submit to and complete background checks in accordance with this administrative regulation no later than September 30, 2018.</p> <p>(2) A child care staff member hired on or after April 1, 2018, shall:</p> <p>(a) Have completed the background checks required in accordance with this administrative regulation and been found to have no disqualifying offense prior to becoming a child care staff member; or</p> <p>(b) 1. Have submitted to the background checks required in accordance with this administrative regulation;</p> <p>2. Not be left unsupervised with a child in care pending the completion of the background checks in accordance with this administrative regulation; and</p> <p>3. Be dismissed or relocated from the residence if the person is found to have a disqualifying background check result.</p>	
Findings:	
<p>General: Based on observation and review of documentation, a staff member was provisionally hired on 5/2/2022 via the KARES Portal. This individual has not yet had their fingerprints collected for the FBI background check. This staff member was observed working alone in the Three-year-old classroom with nine students on the date of the inspection.</p>

Findings:

General: Based on observation, the surveyor entered the Toddler 2 classroom at 10:41 a.m. and observed one staff member with eleven students aged one. A second staff member entered the classroom shortly after the surveyor entering the classroom. The staff person stated that they had left the classroom to use the restroom. It is unknown how long the staff person was left alone with the eleven students. The classroom was over ratio by five students for an undetermined amount of time.

922 KAR 2:120. Section 6. Sleeping and Napping Requirements.

(2) Rest time shall be provided for each child who is not school-age and who is in care for more than four (4) hours.

Findings:

General: Based on interview, this regulatory requirement was not met. During interview it was disclosed that children in the Pre-K 2 and Pre-K 1 classrooms do not take a nap. Staff person in charge stated that this is to prepare the children for Kindergarten and that the parents of the children wish for the children to stay awake while at the facility.
