Findings:

General: Based on Observation, and interview the facility failed to meet this regulatory requirement. At the time of the visit, a tour of the facility with the staff person in charge revealed that three (3) preschool classrooms located in the gym area are no longer being used by the facility and the facility is currently using space (six (6) classrooms) to care for children that have not been approved by the cabinet. The staff person in charge stated that the Fire Marshal approved the facility to use the entire building on 2/11/14 and presented the surveyor with a copy of the Fire Marshal inspection report. Written notification of these changes was not submitted to the cabinet to allow for approval before implementation.

Findings:

General: Based on Observation, the facility failed to provide for the safety of the children. During a tour of the two (2) year old room, the surveyor observed a radio sitting on a shelf next to the television. The radio was plugged into an electrical outlet in the children's play area. The cord was observed hanging loose and was accessible to the children.

General: Based on Review of Documentation, and interview, one (1) staff person did not have evidence of a processed child abuse/neglect check (CAN) on file. The staff person in charge stated that this person was originally hired as a substitute staff person on 8/6/07 and indicated that a previous director "rehired" the staff person 5/1/13 when the staff person started working at the facility full-time. A CAN check application had been filled out by the staff person and signed on 5/14/13; however, it had not been signed by an administrative staff person and had not been submitted for processing. The staff person's original CAN check documentation from 2007 could not be located during the visit. Findings:

General: Based on Review of Documentation, and interview the following was found: 1. One (1) staff person did not have evidence of a processed child abuse/neglect check (CAN) on file. The staff person in charge stated that this person was originally hired as a substitute staff person on 8/6/07 and indicated that a previous director "rehired" the staff person 5/1/13 when the staff person started working at the facility full-time. A CAN check application had been filled out by the staff person and signed on 5/14/13; however, it had not been signed by an administrative staff person and had not been submitted for processing. The staff person's original CAN check documentation from 2007 could not be located during the visit. A review of the staff schedule and an interview with the staff person in charge revealed that this staff person works alone with preschool children on Monday's and Wednesday's. 2. One (1) staff person (hire date: 11/1/13) had a child abuse/neglect check (CAN) that was submitted on 11/8/13; therefore, it was not submitted within the regulatory timeframe. This same staff person had a criminal records check (CRC) that was dated 11/13/13. There was no documentation to verify that the CRC was submitted within the regulatory timeframe.

 - (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.**
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:**
- (a) Nature of the offense;**
 - (b) Length of time that has elapsed since the event; and**
 - (c) Individual's life experiences after conviction, Alford plea, or guilty plea.**
