General: Based on Observation and interview, a caregiver supervised thirteen (13) children, three (3) years to five (5) years old, from 8:45 a.m. to 9:05 a.m. in the preschool room.

(1) Child-care center staff:

(b) Shall provide, prior to employment and every two (2) years thereafter:

- 1. A statement from a health professional that the individual is free of active tuberculosis; or**
- 2. A copy of negative tuberculin results.**

Findings:

General: Based on Review of Documentation, a caregiver hired 3/8/04, had TB documentation on file that was dated 9/9/14. Also, a volunteer, start date 3/4/08, had TB documentation on file that was dated 10/19/10.

340 - Training

922 KAR 2:110. Section 5. Staff Requirements.

(14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:

- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;**
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training; and**
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training completed once every five (5) years.**

Findings:

General: Based on Review of Documentation, a caregiver hired 3/8/04, lacked three (3) hours of training and caregiver hired 7/14/14, had not completed any training hours during the subsequent year of employment.

- (c) Daily attendance records documenting the arrival and departure time of each child, including records that are required in accordance with 922 KAR 2:160, Section 13, if a child receives services from the child-care center through the Child Care Assistance Program;**

Findings:

General: Based on Review of Documentation, twenty-two (22) children had documented their arrival time on the daily attendance record; however, observation determined twenty-three (23) children were present at the center.
