General: Based on interviews, a child had seizure-like activity on 10/08/12, which was due to pediatric head trauma. The child's parent arrived and immediately took the child to the emergency room for treatment. The center failed to notify the cabinet within twenty-four (24) hours.

# Findings:

General: Based on review of documentation and interviews, an infant had what staff thought was a seizure or a sign of being in medical distress at approximately 11:15 a.m. on 10/08/12. The center attempted to contact the parent without success and then made contact with the emergency contact person. Both parent and emergency contact person arrived at approximately 12:15 p.m. The center's medical emergency procedures stated staff should determine the extent of injuries, perform first aid or CPR, call 911 emergency medical service, stay with the child until medical help arrives, and notify the parents or guardian. The center's procedures also stated the director would submit an incident report to the cabinet within twenty-four (24) hours of the incident. The center did not follow their policies and procedures.

# Findings:

General: Based on review of documentation and interviews, the center failed to implement its procedures when a child had seizure-like activity which was due to pediatric head trauma on 10/8/12. The parent and emergency contact were called, but for emergency medical help was not contacted; therefore, the center did not follow its emergency medical procedures on 10/8/12.

#### Findings:

General: Based on interviews, the center failed to meet the health and comfort of a child on 10/8/12. The child's health and comfort was not met from 11:45 a.m. to 12:15 p.m. on 10/08/12, when the child had seizure-like activity and medical help was not called to aid in the child's distress on 10/8/12. The parent arrived and took the child to the hospital.
