(n) Assure that a person acting as a caregiver of a child in care shall not be left alone with a child, if the licensee has not received the results of the background checks as described in 922 KAR 2:280;

## Findings:

General: Based on review of documentation and interview, the surveyor found that a staff member (DOH: 9/12/17) had been permitted to work alone with the children and without the supervision of a qualified staff member prior to the center obtaining results of an out of state criminal record background check. The Director reported that the staff member always worked with another staff member (DOH: 12/19/17). The staff file for the staff member (DOH: 12/19/17) revealed that they were under the age of eighteen (18) and therefore not a qualified staff member for the majority of the time they have been employed.

- 5. The results of background checks conducted in accordance with 922 KAR 2:280;

## Findings:

General: Based on review of documentation and interview, the surveryor found that a staff file (DOH: 9/12/17) did not contain the results of an out of state criminal record background check for a state the staff member has lived in within the past five (5) years. Upon interview, the Director confirmed that an out of state criminal record background check had not been submitted.
