

The staff person then gave that child four (4) to five (5) small pieces of colored construction paper that had been cut into very thin crescents. This was done while the other children waited at the other table with no activity. The child who had the paper and glue then was then told to "put their crescents on the glue". The staff person would take that group into the bathroom to wash their hands. The staff person conducting the activity continued by giving paper with glue and crescent shapes to one child while other children waited for their turn. Eventually the staff person gave two children paper with glue. One (1) of those children was the youngest child in the room. The surveyor observed this child ake her finger and run it through the glue and then lick her finger several times. This happened while the staff person conducting the activity had her back turned as she was helping the other children. Finally the staff person turned around and saw the child licking the glue off of her finger. During the entire time the other staff person was helping children in this group.
