General: Based on Review of Documentation, it was found that the facility's last documented pre-trip inspection was for 09/01/2017. The staff in charge stated that they have not kept up with doing the pre-trip inspection forms.

General: Based on Observation, it was found that there were two (2) bottles in the refrigerator in the infant classroom that were not covered.

General: Based on review of documentation, child enrolled on 04/05/2016 had immunization records that expired on 06/30/2017. Child enrolled on 08/08/16 had immunization records that expired on 06/30/2017.

(b) A written record for each child:

- 1. Completed and signed by the child's parent;**
- 2. Retained on file on the first day the child attends the child-care center; and**
- 3. To contain:**
 - a. Identifying information about the child, which includes, at minimum, the child's name, address, and date of birth;**
 - b. Contact information to enable a person in charge to contact the child's:**
 - (i) Parent at the parent's home or place of employment;**
 - (ii) Family physician; and**
 - (iii) Preferred hospital;**
 - c. The name of each person who is designated in writing to pick-up the child;**
 - d. The child's general health status and medical history including, if applicable:**
 - (i) Allergies;**
 - (ii) Restriction on the child's participation in activities with specific instructions from the child's parent or health professional; and**
 - (iii) Permission from the parent for third-party professional services in the child-care center;**
 - e. The name and phone number of each person to be contacted in an emergency situation involving or impacting the child;**
 - f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;**

Findings:

General: Based on review of documentation, children enrolled on 12/28/2016 and 06/10/2017 did not have a preferred hospital listed. Child enrolled 08/08/2016 did not have physician or preferred hospital listed.

- (d) A description of services provided by the child-care center, including:**
 - 1. Current rates for child care; and**
 - 2. Each service charged separately and in addition to the basic rate for child care;**
- (e) Minimum staff-to-child ratios and group size established in 922 KAR 2:120; and**
- (f) Daily schedule.**

Findings:

General: Based on Review of Documentation, it was found that the facility did not have the civil penalty notice issued by the cabinet during the current licensure year posted in a conspicuous place made available for public inspection.
