General: Based on Interview, the staff in charge indicated that she is the director of the facility, but no paperwork has been submitted to approve her as the director. The staff in charge indicated that the previous director left in September of 2014.

 - 3. Criminal records check for any previous state of residence completed once if:
 - a. The adult resided outside the state of Kentucky in the last five (5) years; and
 - b. No criminal records check has been completed for the adult's previous state of residence. The check shall indicate that the adult has not been convicted of, or has not entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in subparagraph 1 of this paragraph; and
 - 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

155 - Staff Awake on Duty

- (d) Ensure:

General: Based on Review of Documentation, there were three (3) staff who did not have annual evaluations on file and available for review, hire dates 9/4/13, 7/11/13, and 8/31/09.

Findings:

General: Based on Review of Documentation and observation, there was a staff person (music teacher) hired 7/11/13 who did not have a child abuse or neglect check on file. This staff person was observed supervising a group of children by herself. The staff person was supervising seven (7) three (3) year-old children during the relicensure survey.

280 - Altered/Falsified Records

In Compliance

- (1) Effective with the adoption of this administrative regulation, a director shall:
- (o) Assure each mandatory record specified in Section 3 of this administrative regulation has not been altered or falsified;

Employee Records

300 - Background checks/left alone

- (5) An individual described in subsection (4) of this section shall:
- (a) Submit to background checks described in paragraph (b) of this subsection;
 - (b) May be employed or work with a child on a probationary basis for up to ninety (90) calendar days, pending completion of a:
 1. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
 2. Criminal records check required by KRS 199.896(19);
 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
 4. An address check of the Sex Offender Registry; and
 - (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on Review of Documentation, a staff person hired 9/4/13 did not have a criminal records check on file. A staff person hired 7/11/13 did not have a child abuse or neglect check on file. A staff person hired 8/31/09 who had no criminal records check or child abuse or neglect check on file. There were three (3) other staff whose hire dates were not known who did not have a criminal records check or a child abuse or neglect check on file. The staff person hired 7/11/13 was working alone with children.

305 - Background checks/discharged

- (a) An individual whose name is listed on the central registry established by 922 KAR 1:470;

 - (c) An individual who is confirmed by an address check of the Sex Offender Registry and supporting documentation as a registered sex offender;
 - (d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;
 - (e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and
 - (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:
- (a) Nature of the offense;
 - (b) Length of time that has elapsed since the event; and
 - (c) Individual's life experiences after conviction, Alford plea, or guilty plea.

 - b. Location;**
 - c. Date; and**
 - d. Number of clock hours completed;**
 - 5. Every two (2) years, a:**
 - a. Statement from a health professional that the individual is free of active tuberculosis; or**
 - b. Copy of negative tuberculin results; and**
 - 6. For a director, employee, volunteer, or any person with supervisory or disciplinary control over, or having unsupervised contact with, a child in care, the results of a:**
 - a. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;**
 - b. Criminal records check required by KRS 199.896(19);**
 - c. Criminal records check from any previous state of residence completed once if:**
 - (i) The individual resided outside the state of Kentucky in the last five (5) years; and**
 - (ii) No criminal records check has been completed for the individual's previous state of residence; and**
 - d. An address check of the Sex Offender Registry;**

Findings:

General: Based on Review of Documentation and interview, there were five (5) staff whose personnel files were in the office of an absent office staff person and unavailable for review. There were two (2) who had been employed for over a year and pieces of their information was available and there were three (3) new staff who had no information available.

315 - Educational Requirements

Not In Compliance

922 KAR 2:110. Section 5. Staff Requirements.

- (1) Child-care center staff:**
- (a) Hired after January 1, 2009, who have supervisory power over a minor and are not enrolled in secondary education, shall have a:**
- 1. High school diploma;**
 - 2. GED or qualifying documentation from a comparable educational entity; or**
 - 3. Commonwealth Child Care Credential as described in 922 KAR 2:250;**

Findings:

General: Based on Review of Documentation, there were four (4) staff who did not have evidence of meeting the education requirement on file at the center. One (1) staff was hired 8/31/09. The hire dates were unknown for the other three (3) staff.

320 - TB Verification

Not In Compliance

922 KAR 2:110. Section 5. Staff Requirements.

- (1) Child-care center staff:**
- (b) Shall provide, prior to employment and every two (2) years thereafter:**
- 1. A statement from a health professional that the individual is free of active tuberculosis; or**
 - 2. A copy of negative tuberculin results.**

Findings:

General: Based on Review of Documentation, there was one (1) new staff who did not get documentation of being free of TB prior to employment: a staff hired 8/14/14 had a documentation dated 3/15/15. There were four (4) staff who did not have documentation on file, Of these one (1) was a staff person who had a TB skin test in the past but the documentation was now missing (hire date 8/31/09), a staff hired 7/1/13 and 8/31/09 had no documentation on file, and the other three (3) were new staff whose files were unavailable (hire dates were unknown). Finally, there were four (4) staff who had documentation on file but more that two (2) years had lapsed since the prior documentation had been obtained. A staff person hired 8/31/07 had documentation dated 8/16/12 followed by documentation dated 3/18/15. A staff person hired 6/1/13 had documentation dated 6/7/12 followed by documentation dated 3/18/15. A staff person hired 8/1/10 had documentation dated 8/16/12 followed by documentation dated 3/16/15.
