#### Findings:

General: Based on Review of Documentation, the facility failed to complete a child abuse or neglect check using the central registry system and a criminal records check for an employee within ninety (90) calendar days of employment. Employee with hire date 12/11/2013 had not completed a criminal records check required by KRS 199.896(19). The staff member had been employed with the facility for more than ninety (90) days. The staff member in charge reported that the employee is not left alone in the presence of a child in care. The staff member in charge exported that the employee onto have supervisory authority over a child in care. Additionally, an employee with hire date 08/13/2013, had not completed a child abuse and neglect check using the central registry system, or a criminal records check required by KRS 199.896(19). The employee had worked as a volunteer for the facility from 05/26/2011 until 08/01/2011. The facility had completed a child abuse neglect check for the employee on 05/26/2011 and a criminal records check on 05/31/2011. The employee discontinued volunteer services on 08/01/2011, and was hired as an employee of the facility on 08/13/2013. The facility failed to complete a new criminal records and child abuse and neglect check for the employee once hard integrating the facility failed to complete a new criminal records and child abuse and neglect check for the employee on 05/26/2011 and a criminal records check on 05/31/2011. The employee discontinued volunteer services on 08/01/2011, and was hired as an employee had been employee with the facility for more than ninety (90) days. The staff member in charge reported that the employee works from 6:00 a.m., and is never left alone in the presence of a child in care.
