In the bathroom in an unlocked cabinet were numerous chemical cleaning supplies including bleach, tilex, rubbing alcohol without a child safety cap, there also were cans of paint and uncapped cans of spray paint. The chemicals were all on low shelves accessible to the children using the bathroom.
