General: Based on Observation, of the unlocked cabinet located beneath the kitchen sink were cleaning componets that state Keep out of Reach of Children such as Oxy Clean and Fantastic Cleaners. In the bathroom in an unlocked cabinet were numerous chemical cleaning supplies including bleach, tilex, rubbing alcohol without a child safety cap, there also were cans of paint and uncapped cans of spray paint. The chemicals were all on low shelves accessible to the children using the bathroom.

General: Based on Observation, the orange bathroom sink is not in proper working order as it is not draining properly. The water builds up in the sink as hands are washed as the drain is draining very slowly.
