Findings:

General: Based on Observation, upon arrival at the home, the provider was not present in the child care area which is located in the garage; the provider walked out of the main house to meet surveyor at the garage door. An adult female later identified as a volunteer, opened the door for the surveyor and the provider and returned to the couch where she held an infant. Within minutes a second (2nd) adult female, later identified as the assistant, emerged from the rear of the center where she had been changing diapers. For an unknown amount of time, the volunteer was left alone with children and the children failed to be supervised by a qualified adult.

Therefore, the provider was observed to have a total of seven (7) unrelated children for whom she cared when she was only certified to care for six (6) unrelated children. The provider acknowledged the finding.

Within minutes a second (2nd) adult female, later identified as the assistant, emerged from the rear of the center where she had been changing diapers. Review of staff files revealed that neither woman had a criminal records back ground check and was unauthorized to be left alone with children.
