Review of the staff files revealed two (2) files for staff members with the hire dates 09/28/2018 and 10/17/2018 did not contain documentation of a high school diploma, GED, or Commonwealth Child Care Credential.

Interview with the staff in charge revealed this information was not available at the time of survey.

Review of staff files revealed four (4) files for staff members with the hire dates of 08/09/2017, 08/14/1997, 08/30/2019, and 09/28/2018, failed to have a statement from a health professional that the individual is free of active tuberculosis.

Interview with the staff in charge revealed this information was unavailable at the time of survey.
