General: Based on Review of Documentation, the center was cited for a lack of emergency evacuation plan in the survey from 09/21/2012 and did not follow the plan of correction that was submitted to the cabinet. Interview with the site director revealed that she has not had time to complete the evacuation plan.

  - 4. A copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

### 155 - Staff Awake on Duty

  - (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

#### Findings:

General: Based on Review of Documentation, an employee with the hire date of 12/31/2012 did not have the Child Abuse and Neglect (CAN) Check submitted until 08/15/2013 therefore, the director did not abide by 922 KAR 1:470 by submitting a CAN Check within five days of hire. Interview with site director revealed that the employee with the hire date of 12/31/2012 did not work alone with the children prior to obtaining the results of the CAN Check. Further review of documentation revealed that an employee with an original hire date of 05/10/2012 and rehire date of 03/15/2013 did not have a Criminal Record Check (CRC) or Child Abuse and Neglect (CAN) Check ran after she returned to the center after severing employment. Interview with the site director revealed that the employee with the hire date of 03/15/2013 does not work alone with children.
