Interview with site director revealed that the employee with the hire date of 12/31/2012 did not work alone with the children prior to obtaining the results of the CAN Check. Further review of documentation revealed that an employee with an original hire date of 05/10/2012 and rehire date of 03/15/2013 did not have a Criminal Record Check (CRC) or Child Abuse and Neglect (CAN) Check ran after she returned to the center after severing employment. Interview with the site director revealed that the employee with the hire date of 03/15/2013 does not work alone with children.
