<p>922 KAR 2:120. Section 5. Infant and Toddler Play Requirements.</p> <p>(2) Except in accordance with subsection (3) of this section or Section 2(2)(c) of this administrative regulation, an infant or toddler under twenty-four (24) months of age shall not participate in an activity with an older child for no more than one (1) hour per day.</p> <p>(3) If a toddler is developmentally appropriate for a transition to a preschool age group, a toddler may participate in an activity with an older child for more than one (1) hour per day if:</p> <p>(a) Space for the toddler is available in the preschool-age group;</p> <p>(b) The staff-to-child ratios and group sizes are maintained based on the age of the youngest child;</p> <p>(c) The center has a procedure for listing a transitioning toddler on attendance records, including a specific day and time the toddler is with either age group; and</p> <p>(d) The child care center has obtained the signature and approval of the toddler's parent on the toddler's transition plan.</p>	
<p>Findings:</p> <p>General: Based on interviews with staff, the child care center failed to comply with regulatory programming requirements, i.e., two-year-old children were combined with children who ranged in age up to five (5) years old, for more than one (1) hour per day. Staff interviews revealed the Preschool classroom had nine (9) children and one (1) staff in the room. Further interview revealed the children in the classroom were together for more than one (1) hour and ranged in age from two (2) to five (5) years old.</p>
