(3)(a) Each center shall maintain a child-care program that assures each child will be:

- 1. Provided with adequate supervision at all times by a qualified staff person who:
- a. Ensures the child is within scope of vision and range of voice; or
- b. For a school-age child, within scope of vision or range of voice;

Findings:

General: Based on Observation, a child poked his finger in the front grill of an operating box fan while the caregiver diapered a child in the restroom in the two year olds' room. The child was not within the caregiver's scope of vision and the caregiver was not aware of the child's actions.

General: Based on Observation, a caregiver supervised seven (7) children from 10:00 am until 11:40 am in the two year olds' room. The youngest child was a one-year-old.

(2)(b) The age of the youngest child in the group shall determine the:

- 1. Staff-to-child ratio; and
- 2. Maximum group size.

Findings:

General: Based on Review of Documentation, a caregiver supervised seven (7) children from 10:00 am until 11:40 am in the two year olds' room. The youngest child was a one-vear-old.

General: Based on Review of Documentation, a caregiver, hired on 08/01/16, did not have an annual written performance evaluation on file.

General: Based on Review of Documentation and interview, there was no documentation of a parent/family involvement activity being held.

General: Based on Review of Documentation, a caregiver, hired on 08/01/16, did not complete pediatric abusive head trauma training.

General: Based on Review of Documentation, a daily planned program of activities was not developed in the school-age room. The posted daily planned program of activities was dated 12/26/16 and was not being followed in the two year olds' room.

Findings:

General: Based on Observation, a one-year-old child was combined with five (5), two-year-old children for approximately two and a half (2 1/2) hours in the two year olds' room on 10/12/17.

460 - Inaccessible Items **Not In Compliance**

922 KAR 2:120. Section 3. General Requirements.

- (7) Except in accordance with subsection (8) of this section, the following shall be inaccessible to a child in care:
- (a) Toxic cleaning supplies, poisons, and insecticides;
- (b) Knives and sharp objects;
- (c) Matches, cigarettes, lighters, and flammable liquids;
- (d) Plastic bags;
- (e) Litter and rubbish;
- (f) Bar soap: and
- (g) Personal belongings and medications of staff.

Findings:

General: Based on Observation, a caregiver's open purse, which contained a pack of cigarettes and an inhaler, was on top of a two (2) tall foot shelf in the two year olds' room. A large container of Lysol wipes was on counter beside the sink and a roll of plastic trash bags was on the lid of the toilet tank in the two year olds' restroom. A caregiver's jacket hung on back of a chair in the school age room and in the one year olds' room. An operating box fan was on top of a two (2) foot tall shelf in the two-year-olds' room. All of these items were accessible to children.

 - 2. Before and after eating or handling food;
 - 3. After toileting or diaper change;
 - 4. After handling animals;

 - 7. After outdoor or indoor play time.

Findings:

General: Based on Observation, a child did not wash her hands with liquid soap and warm running water upon arrival in the two year olds' room.

600 - Staff Hygiene/Handwashing

- (5) Staff shall:
- (a) Maintain personal cleanliness;
- (b) Conform to hygienic practices while on duty; and
- (c) Wash their hands with liquid soap and running water:
 - 1. Upon arrival at the center;
- 2. After toileting or assisting a child in toileting;
- 3. Before and after diapering each child;
- 4. After wiping or blowing a child's or own nose;
- 5. After handling animals;
- 6. After caring for a sick child;
- 7. Before and after feeding a child or eating;
- 8. Before dispensing medication; and
- 9. If possible, before administering first aid.

Findings:

General: Based on Observation, a caregiver failed to wash her hands with liquid soap and warm running water after wiping a child's nose in the two year olds' room.

625 - Diaper Changing Area/Surface

- (10) When a child is diapered, the child shall:
- (b) Be placed on a surface that is:
- 1. Clean;
- 2. Padded;
- 3. Free of holes, rips, tears, or other damage;

- 5. Easily cleaned; and
- 6. Free of any items not used for diaper changing.

Findings:

General: Based on Observation, a tear was in the surface of the diapering mat in the infants' room.

635 - Diapering Practice

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements. (12) Staff shall disinfect the diapering surface after each child is diapered.

(13) If staff wear disposable gloves, the gloves shall be changed and disposed after each child is diapered.

Findings:

General: Based on Observation, a caregiver failed to sanitize the diapering surface after diapering a child in the two year olds' room.

General: Based on Observation, a one (1) ounce tube of A and D diaper rash ointment was not labeled to indicate for whom it was intended and was stored, unlocked, in a plastic tub under the diapering station in the two year olds' restroom.

General: Based on Observation, a red and blue nap mat was torn and exposed foam in the one year olds' and in the two and three year olds' room. Two (2) red and blue and two (2) green and blue nap mats were torn and exposed foam in the school age room.

General: Based on Observation, three (3) children used highchairs that did not have safety straps in the dining room. The manufacturer recommended to always secure child in the restraints.

General: Based on Review of Documentation, a child, first date of attendance on 10/29/17, had an immunization certificate on file with no documented validity date.

Findings:

General: Based on Review of Documentation, a child, first date of attendance on 11/11/15; a child, first date of attendance on 06/10/13; a child, first date of attendance on 07/27/15, and a child, first date of attendance on 10/29/15, each did not have information on file for the person in charge to contact the child's preferred hospital. A child, first date of attendance on 07/27/15, did not have information on file for the person in charge to contact the child's physician. A child, first date of attendance on 06/10/13, did not have the phone number for each person to be contacted in an emergency situation involving or impacting the child.

Ten (10) children did not have a documented arrival time on 10/12/17.
