- (b) Found by the cabinet to have abused or neglected a child, pursuant to 922 KAR 1:470;
- (c) Placed on the Sex Offender Registry; or
- (d) Determined by a physician to have a health condition that renders the person unable to care for children.

Findings

265 - Health, Safety, Comfort

General: Based on Interview, the staff person in charge stated that an employee who had a completed CAN check with a substantiated child neglect allegation, had worked three days at the facility. The staff person in charge said that she had received the CAN check results on January 22, 2016, but had not noticed that there was a substantiation marked on the results. The employee worked three days after the CAN results were received. The staff person in charge stated that the employee never worked alone with the children and that she would be terminated immediately.
