General: Based on Observation, and interview there was what appeared to be black mold, growing on the ceiling of the closet in the two (2) year-old room. The black mold was located next to the air vent in the closet that circulates air flow out. The closet is used to store the children's cots and some extra toys. The closet is gated off from the children.

Findings:

General: Based on Review of Documentation, and interview the closet, located inside the two (2) year-old room contained a stained ceiling, an uneven surface on the ceiling (where a repair was made, but it was not flush), and what appeared to be black mold growing on the ceiling and wall next to the air vent. It appeared that the roof must have leaked and the water came out through the ceiling of the 2 year-old room closet. In addition, the celling in the stairwell that leads upstairs to the two (2) year-old room was stained.
