Building 1 - School Age: Based on observation, a child held a another child's legs and dragged the child for approximately six (6) feet across the floor. The caregiver was on the opposite side of the classroom, with her back turned towards the children's activities.

Building 1 - School age room: A child continuously rolled a truck into a child's leg, while the child yelled, several times, for him to stop. The caregiver walked beside the two children and did not say anything until the surveyor suggested the child might have a bruise on his leg.
