General: Based on review of documentation, a staff, hired on 12/20/19, did not have education verification on file.

410 - Training Not In Compliance

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;

General: Based on review of documentation, a staff, hired on 01/02/19, and a staff, hired on 10/15/18, each did not complete one and a half (1 ½) hours of cabinet approved pediatric abusive head trauma within the first year of employment.

General: Based on review of documentation, the program of activities was not developed and posted in the one and two-year-olds' room.

510 - Appropriate Use of Food Not In Compliance

- (2) Food shall not be:
- (a) Used for reward;
- (b) Used for discipline;
- (c) Withheld until all other foods are consumed; or
- (d) Served while viewing electronic devices.

Findings:

General: Based on observation, a caregiver served a bottle to a toddler, who laid across the caregiver's lap and in the caregiver's arm, while the toddler viewed an electric tablet in the one-year and two-year-olds' room.

Premises Not In Compliance

525 - Items Accessible Only During Activity

- (8) The following shall be inaccessible to a child in care unless under direct supervision and part of planned program of instruction:
- (a) Knives and sharp objects;
- (b) Litter and rubbish;
- (c) Bar soap; and
- (d) Plastic bags not used for personal belongings.

Findings:

General: Based on observation, three (3) plastic bags were stored in a three (3) drawer plastic storage organizer in the one-year and two-year-olds' room. A plastic bag was stored in the top drawer of a four (4) drawer plastic storage organizer in the preschool room. These items were accessible to children and were not a part of the planned program of instruction

Hygienic Practices

655 - Child Personal Care/Handwashing

- (b) Except as established in paragraph (c) of this subsection, wash his or her hands with liquid soap and warm running water:

- b. Within thirty (30) minutes of arrival for school-age children;
- 2. Before and after eating or handling food;
- 3. After toileting or diaper change;
- 4. After handling animals;
- 5. After touching an item or an area of the body soiled with body fluids or wastes; and
- 6. After outdoor or indoor play time; and
- (c) Use hand sanitizer or hand-sanitizing wipes if liquid soap and warm running water are not available in accordance with paragraph (b) of this subsection. The child shall wash the child's hands as soon as practicable once liquid soap and warm running water are available.

Findings:

General: Based on observation, two (2) children did not wash their hands with liquid soap and warm running water after they were diapered in the one-year and two-year olds' room. A child did not wash his hands with liquid soap and warm running water upon arrival to the preschool room at 10:50 am.

660 - Staff Hygiene/Handwashing

- 2. After toileting or assisting a child in toileting;
- 3. Before and after diapering each child;
- 4. After wiping or blowing a child's or own nose;
- 5. After handling animals;
- 6. After caring for a sick child;
- 7. Before and after feeding a child or eating;
- 8. Before dispensing medication;
- 9. After smoking or vaping; and
- 10. If possible, before administering first aid; and
- (d) Use hand sanitizer or hand-sanitizing wipes if liquid soap and warm running water are not available in accordance with paragraph (c) of this subsection. The staff shall wash the staff's hands as soon as practicable once liquid soap and warm running water are available.

Findings:

General: Based on observation, a staff did not wash her hands with liquid soap and warm running water after she wiped a child's nose in the one-year and two-year-olds' room.

- (a) Be available to provide prompt and proper first aid treatment;
- (b) Be stored out of reach of a child;
- (c) Be periodically inventoried to ensure the supplies have not expired;
- (d) If reusable, be:
- 1. Sanitized; and
- 2. Maintained in a sanitary manner; and
- (e) Include:
- 1. Liquid soap;
- 2. Adhesive bandages;
- 3. Sterile gauze;
- 4. Medical tape;
- 5. Scissors;
- 6. A thermometer;
- 7. Flashlight;
- 8. Cold pack;
- 9. First aid book;
- 10. Disposable gloves; and
- 11. A cardiopulmonary resuscitation mouthpiece protector.

Findings:

General: Based on observation, a CPR mouthpiece and flashlight were stored in an unlocked cabinet under the sink and were accessible to children in the school-age children's

730 - Medication Not In Compliance

922 KAR 2:120. Section 7. First Aid and Medicine.

- (6) Medication, including refrigerated medication, shall be:
- (a) Stored in a separate and locked place, out of the reach of a child unless the medication is:
- 1. A first aid supply and is maintained in accordance with subsection (1) of this section;
- 2. Diaper cream, sunscreen, or toothpaste. Diaper cream, sunscreen, or toothpaste shall be inaccessible to a child;
- 3. An epinephrine auto-injector. A licensed child-care center shall comply with KRS 199.8951 and 311.646, including:
- a. An epinephrine auto-injector shall be inaccessible to a child;
- b. A child-care center shall have at least one (1) person onsite who has received training on the administration of an epinephrine auto-injector if the child-care center maintains an epinephrine auto-injector;
 - c. A child-care center shall seek emergency medical care for a child if an auto-injector is administered to the child; and
- d. A child-care center shall report to the child's parent and the cabinet in accordance with 922 KAR 2:090, Section 12(1)(b) if an epinephrine auto-injector is administered to a child; or
- 4. An emergency or rescue medication for a child in care, such as medication to respond to diabetic or asthmatic condition, as prescribed by the child's physician. Emergency or rescue medication shall be inaccessible to a child in care;
- (b) Kept in the original bottle; and
- (c) Properly labeled.
- (7) Medication shall not be given to a child if the medication's expiration date has passed.

Findings:

General: Based on observation, a bottle of sunscreen and a bottle of insect repellant were not labeled to indicate to whom they belonged and were stored unlocked in the top drawer of a five (5) drawer plastic storage organizer in the two-year-olds' room. A one ounce tube of Hydrocortisone cream was not labeled to indicate to whom it belonged in the preschool room.

- (9) Bottles shall be:
- (a) Individually labeled;
- (b) Promptly refrigerated;
- (c) Covered while not in use; and

General: Based on observation, a bottle was not covered in the one-year and two-year-olds' room. Also, a bottle was not labeled in the one and two-year-olds' room.

General: Based on review of documentation, a child, first date of attendance on 06/14/19; a child, first date of attendance on 08/21/19, and a child, first date of attendance on 04/26/18, did not have the name of each person designated in writing to pick-up the child. A child, first date of attendance on 06/14/19, did not have the name and phone number of each person to be contacted in an emergency involving or impacting the child.
