Findings:

General: Based on Observation, it was found that one (1) staff person was supervising seventeen (17) children ages six (6) years to eleven (11) years old while they were doing their homework. The required staff to child ratio when a six (6) year old is present is one (1) staff person for every fifteen (15) children. The staff person was over ratio by two (2) children. In addition, it was found that there were thirty-two (32) children in the second and third grade group. The youngest child in the group was seven (7) years old, thus requiring a maximum group size of thirty (30) children. The group exceeded the maximum group size by two (2) children.
