Findings:

Based on review documentation, the surveyor found a basic field trip permission form in each child's file for walking field trips and field trips that require transportation. It is important to note that transportation services are not listed on the facility's license. The surveyor asked the Director if the facility transports children. The Director stated that during the Summer the children are transported to and from the movies every Thursday. She stated that Scott County Public School provides the bus. She stated that they have transported the children to and from field trips since 2010. The Director presented a transportation contract that was dated 8/25/2010 and was signed by a representative of Scott County's transportation department. The Director stated that she thought that transportation services had been approved. However, further review found that the Division of Regulated Child Care never received a request to add transportation services. Furthermore, the transportation services category on past renewal applications that have been submitted by Scott County Public Schools on behalf of the after school program has never been checked.

Findings:

General: Based on Review of Documentation, a staff person hired on 1/5/16 did not have any documentation on file to verify if the child abuse/neglect check had been requested. The Director stated that she had to re-submit the document in order for it to be processed. This staff person was observed in the gym with a qualified staff person. However, the staff person stated that she was in charge of the Kindergarten group and the other staff person was in charge of the First grade group. She stated, "We separate into different areas." At approximately 3:40 p.m. the surveyor observed this staff person alone with her group of children as they walked into the office area to retrieve a rolling cart of toys. (2) Another staff person hired on 1/5/16 had the results of a child abuse/neglect check. However, the document was dated 1/26/16. The CA/N check was not requested within five (5) days of hire as required by the regulations. (3) A staff person who was hired by Scott County Schools in 9/20/06 to work as an aide in the extended day Kingergarten program (which is no longer in existence) recently started to sub for the after school program. The surveyor reviewed this staff person's background checks because this person was not listed in KICCS (Kentucky Integrated Child Care System) from previous inspections. The surveyor found that the staff person's central registry check (CA/N) was stamped but the results were not checked. The results box was left blank at the bottom of the document.
