- (1) A child-care center shall maintain:
- (e) A current personnel file for each child-care center staff person to include:
- 1. Name, address, date of birth, and date of employment;
- 2. Proof of educational qualifications;
- 3. Record of annual performance evaluation;
- 4. Documentation of compliance with tuberculosis screening in accordance with Section 11(1)(b) of this administrative regulation; and
- 5. The results of background checks conducted in accordance with 922 KAR 2:280;

## Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. The facility did not have the results of the background check conducted in accordance with 922 KAR 2:280 for the staff. The finger-print page was on file for a staff hired on 7/01/1984 and for a substitute staff hired on 7/01/1987. The KARES system indicated that both staff were eligible for employment.

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 1/2) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and onehalf (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

## Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. A substitute staff member hired on 7/01/1987, did not complete 15 early care and education training hours during the completed training year. Three training hours were found in the ECE-TRIS system.

General: Based on observation, this regulatory requirement was not met. A stack of discarded wooden privacy fence sections were located in the outdoor play area. The pile of wooden fencing contained some exposed sharp nails.

- (a) Constructed of safe material;
- (b) Stable; and
- (c) In good condition.

### Findings:

General: Based on observation, this regulatory requirement was not met. Five sections of the wooden privacy fence in the outdoor play area had fallen down and were located in the yard. The outdoor play area was not adequately fenced and the fence was not in good condition.
