General: Based on observation upon arrival at the facility, children were on the playground. The surveyor noted that the gate to the playground was not attached and was lying on the ground next to the fence. Interview with the staff person in charge found that the playgrounds were new and had not been inspected by the Cabinet before being used. The staff person in charge stated that the fence gate was down so equipment could be brought in to spread the mulch around the area and had not been put back in place.
