The staff member lived in Illinois within the last five years. The staff member was not working alone during the renewal inspection.</p> <p>2. A staff member that was hired on 10/15/19, did not have written evidence of completing an out-of-state criminal background check. The staff member lived in Florida within the last five years. The staff member was not working alone during the renewal inspection.</p>

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. A staff hired on 9/19/18, did not have a current evaluation on file.

- 1. Name, address, date of birth, and date of employment;**

- 3. Record of annual performance evaluation;**
- 4. Documentation of compliance with tuberculosis screening in accordance with Section 11(1)(b) of this administrative regulation; and**
- 5. The results of background checks conducted in accordance with 922 KAR 2:280;**

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. Four staff files did not have written documented dates of hire. The staff in charge verbally gave the surveyor the hire dates of these staff members.

390 - Educational Requirements**Not In Compliance****922 KAR 2:090. Section 11. Staff Requirements.****(1) Child-care center staff:****(a) Hired after January 1, 2009, who have supervisory power over a minor and are not enrolled in secondary education, shall have a:**

- 1. High school diploma;**
- 2. GED or qualifying documentation from a comparable educational entity; or**
- 3. Commonwealth Child Care Credential as described in 922 KAR 2:250;**

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. The following was found:

1. A staff hired on 10/24/19, did not have proof of education on file.
2. Two staff members hired on 10/15/19, did not have proof of education on file.
3. A staff hired on 11/18/19, did not have proof of education on file.
4. A staff hired on 7/31/19, did not have proof of education on file.
5. A staff hired on 1/25/19, did not have proof of education on file.
6. A staff hired on 7/16/19, did not have proof of education on file.
7. A staff hired on 12/03/19, did not have proof of education on file.

395 - TB Verification**Not In Compliance****922 KAR 2:090. Section 11. Staff Requirements.****(1) Child-care center staff:****(b) Shall provide, prior to employment and every two (2) years thereafter:**

- 1. A statement from a health professional that the individual is free of active tuberculosis; or**
- 2. A copy of negative tuberculin results.**

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. The following was found:

1. A staff hired on 12/03/19, did not have written documentation that they are free of active TB or a copy of the results of a negative tuberculin test on file.
2. A staff hired on 11/01/17, did not have a current copy of a TB skin test on file. The TB skin test on file was dated 11/02/17.
3. A staff hired on 6/14/19, did not have a current copy of a TB skin test on file. The TB skin test on file was dated 11/20/17.

410 - Training

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:**
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;**
 - (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and**
 - (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.**

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. The following was found:

1. A staff hired on 11/01/17, did not complete fifteen hours of cabinet-approved early care and education training within their completed training year. This staff member completed three hours of training. In addition, this staff did not have current pediatric abusive head trauma training on file. The pediatric abusive head trauma training on file was dated 9/23/13. The ECE-TRIS system was reviewed.
2. A staff hired on 9/19/18, did not complete 15 hours of cabinet-approved early care and education training within their completed training year. This staff member completed 12 hours of training. The ECE-TRIS system was reviewed.
3. A staff member hired on 3/27/17, did not have a current pediatric abusive head trauma training on file. The pediatric abusive head trauma training on file was dated 3/27/17. The ECE-TRIS system was reviewed.
4. A staff hired on 4/15/19, did not complete orientation training within three months of employment. The ECE-TRIS system was reviewed.
5. A staff hired on 7/31/19, did not completed orientation training within three months of employment. The ECE-TRIS system was reviewed.
6. A staff hired on 7/16/19, did not complete orientation training within three months of employment. The ECE-TRIS system was reviewed.

General: Based on observation, this regulatory requirement was not met. The following was found:

1. Bathroom #2, located in the hallway, contained a cracked light switch plate.
2. The bathroom located inside the Terrific Tot's Room contained a large accumulation of extra toys and equipment. The area contained a cot, a bookshelf, chairs, children's books, and toys. The toilet and sink in the bathroom could not be accessed.

General: Based on observation, this regulatory requirement was not met. The hall bathroom #1 contained a diaper changing pull down station that was not padded.

- (1) All toys and furniture contacted by a child shall be:**
- (a) Kept clean and in good repair; and**
 - (b) Free of peeling, flaking, or chalking paint.**

Findings:

General: Based on observation, this regulatory requirement was not met. A toy shelf in the Kinder Kids Room contained areas of chipped paint on the surface.

820 - Indoor/Outdoor Equipment

922 KAR 2:120. Section 11. Toys and Furnishings.

(2) Indoor and outdoor equipment shall:

- (a) Be clean, safe, and in good repair;**
- (b) Meet the physical, developmental needs, and interests of children of different age groups;**
- (c) Be free from sharp points or corners, splinters, protruding nails or bolts, loose or rusty parts, hazardous small parts, lead-based paint, poisonous material, and flaking or chalking paint; and**
- (d) Be designed to guard against entrapment or situations that may cause strangulation.**

Findings:

General: Based on observation, this regulatory requirement was not met. The refrigerator in the Terrific Tot's Room contained a yellow sticky substance in the bottom of the unit.

- (c) Be forty (40) degrees Fahrenheit or below.**

Findings:

General: Based on observation, this regulatory requirement was not met. The refrigerator in the Terrific Tot's Room did not contain a thermometer. This is where the bottles were stored.

1050 - Bottles

922 KAR 2:120. Section 8. Kitchen Requirements.

(9) Bottles shall be:

- (a) Individually labeled;**
- (b) Promptly refrigerated;**
- (c) Covered while not in use; and**
- (d) Consumed within one (1) hour of being heated or removed from the refrigerator.**

Findings:

General: Based on observation, this regulatory requirement was not met. The refrigerator in the Terrific Tot's Room contained an uncovered bottle. The refrigerator in the Bouncing Babies Room contained an uncovered and an unlabeled bottle.

- 1. Completed and signed by the child's parent;**
- 2. Retained on file on the first day the child attends the child-care center; and**
- 3. To contain:**
 - a. Identifying information about the child, which includes, at a minimum, the child's name, address, and date of birth;**
 - b. Contact information to enable a person in charge to contact the child's:**
 - (i) Parent at the parent's home or place of employment;**
 - (ii) Family physician; and**
 - (iii) Preferred hospital;**
 - c. The name of each person who is designated in writing to pick-up the child;**
 - d. The child's general health status and medical history including, if applicable:**
 - (i) Allergies;**
 - (ii) Restriction on the child's participation in activities with specific instructions from the child's parent or health professional; and**
 - (iii) Permission from the parent for third-party professional services in the child-care center;**
 - e. The name and phone number of each person to be contacted in an emergency involving or impacting the child;**
 - f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;**

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. The following was found:

1. A child's enrollment paperwork was missing a physician's name and phone number. The child was enrolled on 10/23/19.
2. A child's enrollment paperwork was missing a physician's phone number. The child was enrolled on 8/05/19.
