General: Based on interview and review of documentation, one staff member hired 9/21/2020, is under 18 years of age. This individual did not have a Child Abuse and Neglect background check on file for review. The staff person in charge stated that this individual is always paired with a qualified adult.

General: Based on observation, there was a large hole in the wall behind the play kitchenette in the Terrific Tots classroom. Additionally, drywall was chalking on the window seal in the Busy Bees classroom.

Findings:

General: Based on observation, items not used for diapering were placed onto the diaper changing space in the Busy Bee's classroom.

700 - Children's Individual Items

- (14) Combs, towels or washcloths, brushes, and toothbrushes used by a child shall be:
- (a) Individually stored in separate containers; and
- (b) Plainly labeled with the child's name.

Findings:

General: Based on observation, several cloth children's items were protruding from cubbies and touching one another in the Kinder's classroom. This method of storage promotes cross contamination of germs and bacteria.

- 1. An individual bed, a two (2) inch thick waterproof mat, or cot in good repair; and
- 2. Bedding that is in good repair and is changed:
- a. Weekly; or
- b. Immediately if it is soiled or wet.

Findings:

General: Based on observation, the Bright Butterflies classroom had nine mats that had busted seams. The foam underneath was exposed rendering the mat unable to be properly sanitized. Additionally, the Talented Tykes classroom had seven mats with exposed foam, and the Shining Stars had four mats with frayed edges exposing the foam underneath.

General: Based on observation, the Bright Butterflies classroom had crayon markings on the back of the blocks shelf. Additionally, the Super Sprouts classroom had tape residue that had started to accumulate dirt and grime on the block and music shelf.

General: Based on review of documentation, four children's files did not contain consent for emergency medical treatment.
