Reports.</b></p> <p>(1) The following shall be reported to the cabinet or designee and other agencies specified in this section within twenty-four (24) hours from the time of discovery:</p> <ul style="list-style-type: none"> <li>(a) Communicable disease, which shall also be reported to the local health department pursuant to KRS 214.010;</li> <li>(b) An accident or injury to a child that requires medical care initiated by the child-care center or the child's parent;</li> <li>(c) An incident that results in legal action by or against the child-care center that:               <ul style="list-style-type: none"> <li>1. Affects a child or staff person; or</li> <li>2. Includes the center's discontinuation or disqualification from a governmental assistance program due to fraud, abuse, or criminal conviction related to that program;</li> </ul> </li> <li>(d) An incident involving fire or other emergency, including a vehicular accident when the center is transporting a child receiving child care services;</li> <li>(e) A report of child abuse or neglect that:               <ul style="list-style-type: none"> <li>1. Has been accepted by the cabinet in accordance with 922 KAR 1:330; and</li> <li>2. Names a director, employee, volunteer, or person with supervisory or disciplinary control over, or having unsupervised contact with, a child in care as the alleged perpetrator; or</li> </ul> </li> <li>(f) An individual specified in Section 6(4) of this administrative regulation meeting a disqualifying criterion or background check result pursuant to 922 KAR 2:280.</li> </ul> <p><b>Findings:</b></p> <p>General: Based on review of documentation and interviews, the surveyor found that an incident involving a two year old child that medical care was sought for on 06/01/21 was not reported to the Cabinet by the child-care center within twenty-four (24) hours from the time of discovery.</p>	
<b>210 - Licensee Responsibility</b>	<b>Not In Compliance</b>
<p><b>922 KAR 2:090. Section 8. General.</b></p> <p>(1) A licensee shall:</p> <ul style="list-style-type: none"> <li>(a) Be responsible for the operation of the child-care center pursuant to this administrative regulation, 922 KAR 2:120, and 922 KAR 2:280; and</li> <li>(b) Protect and assure the health, safety, and comfort of each child.</li> </ul> <p><b>Findings:</b></p> <p>General: Based on interviews, the surveyor learned that a two year old child woke up from a nap unresponsive and shaking uncontrollably on 06/01/21. During interviews, the surveyor learned that the two year old child shook uncontrollably for approximately seven (7) to ten (10) minutes, appeared to not be able to stop himself from shaking, and was not responsive when being talked to by staff persons; therefore, the health, safety, and comfort of the child was compromised. Based on review of the Incident Report on Brightwheel dated 06/01/21, the surveyor learned that when the two year old child woke up from his nap "he started crying out, mumbling, and proceeded to shake uncontrollably." The Incident Report stated that the two year old child "did not respond to the two (2) staff persons when being talked too."</p>

<div>922 KAR 2:090. Section 10. Director Requirements and Responsibilities. (1) A director shall: (l) Notify the parent immediately of an accident or incident requiring medical treatment of a child;</div>	
<b>Findings:</b>  General: Based on interviews, the surveyor learned that the parents of a two year old child were not notified immediately after an incident that occurred on 06/01/21 involving the child and a possible illness that may have required medical treatment of the child. Based on interviews, the surveyor learned that an Incident Report was entered on Brightwheel on 06/01/21; however, the reports have to be approved before they are sent out. Through interviews, the surveyor learned that the parents were not notified of the incident involving the two year old child until after the child was picked up from the child-care center.
