Food.</b></li> </ol> <p><b>Findings:</b></p> <p>General: Based on interview and review of documentation, the surveyor found that two (2) different staff have screamed, yelled in a harsh tone, and/or yelled at the children using loud language. These incidents occurred within the child care center while the children were being cared for by the staff persons. At least one (1) staff person acknowledged to her child care center co-workers that she was overwhelmed at times.</p> <p>Therefore, the children were subjected to language that was inappropriate.</p> <p>Staff-in-charge stated that she had a meeting with the staff and reminded them how they should talk to children and how to handle classroom stress. Staff-in-charge stated that a staff person quit after the meeting due to being overwhelmed.</p>
