Implementation and Enforcement.</b></p> <p>(1) A person who is a child care staff member prior to January 1, 2018, shall submit to and complete background checks in accordance with this administrative regulation no later than September 30, 2018.</p> <p>(2) A child care staff member hired on or after April 1, 2018, shall:</p> <p>(a) Have completed the background checks required in accordance with this administrative regulation and been found to have no disqualifying offense prior to becoming a child care staff member; or</p> <p>(b) 1. Have submitted to the background checks required in accordance with this administrative regulation;</p> <p>2. Not be left unsupervised with a child in care pending the completion of the background checks in accordance with this administrative regulation; and</p> <p>3. Be dismissed or relocated from the residence if the person is found to have a disqualifying background check result.</p>		
<p><b>Findings:</b></p> <p>General: Observation in the one-year-old revealed there was one (1) staff member working alone with five (5) children. Review of documentation revealed the records for the above-mentioned staff member with the hire date of 06/08/2021 did not contain background checks. Review of the KARES system revealed the checks had not been submitted as of 8/13/2021.</p>
