General: Based on interview with staff, it was determined that the director failed to ensure the implementation of the program's procedure of receiving children into the program whom have been escorted by an employee of the school. i.e., observation revealed that one child at approximately 2:55 p.m. and one child at approximately 3:25 p.m. walked unsupervised into the program's licensed space to store their belongings without a staff member to receive them, then proceeded to walk unsupervised down a hallway to another area of the program's licensed space to be received by a staff member. Further observation revealed another group of three children walked unsupervised into the program's licensed space at approximately 3:30 p.m. and lingered in the area for five minutes before walking unsupervised down a hallway to another area of the program's licensed space to be received by a staff member.


