Findings:

General: Based on review of documentation, the following was found:

1. There is no one on duty and present with children that is currently certified in Adult CPR from 4:00 p.m. to 5:30 p.m. The facility provides school-age care. 2. The staff designated as a van driver for the facility did not have evidence of current CPR/First Aid training on file in the facility. There is no monitor on the van with the driver.

General: Based on observation, it was found that the black garden liner was coming up through the mulch in several areas on the playground. The liner poses a tripping hazard to the children in care.

General: Based on observation, it was found that there were two large mushrooms growing on one of the logs on the playground. Another log was very rough and the bark had been chipped away. This poses a risk of splinters to the children in care.
