Findings:

General: Based on observation, interview and review of documentation, the child care center failed to comply with regulations regarding staffing requirements. Review of a written incident report from 03/29/2019 and interview with the director and two (2) staff members revealed on 03/29/2019 the child care center exceeded the minimum staff to child ratio and maximum group size for a group of children with the age of the youngest child being two-years-old.

On 03/29/2019, the playground had twenty-one (21) children present in the age range of two-years-old, in the care of the two (2) staff members.

Findings:

General: Based on observation and interview, the child care center failed to comply with regulations regarding director requirements. Interview with the director and two (2) staff members revealed on two (2) separate incidents (03/27/2019 and 03/29/2019) they failed to assure the health, safety, and comfort of a two-year-old child who was bitten by another child

Interview with director and two (2) staff members revealed there was a child that had been known to be the aggressor toward the two-year-old child, resulting in the two-year-old child being bitten on the two (2) named occasions and two (2) other prior occasions before the 03/27/2019 incident.
