1 staff for 25 children

Director Requirements

265 - Health, Safety, Comfort

Not In Compliance

922 KAR 2:110. Section 4. Director Requirements and Responsibilities.

(1) Effective with the adoption of this administrative regulation, a director shall:

(l) Provide for the health, safety, and comfort of each child;

Findings:

General: Based on Interview, and review of documentation it was determined that the child care center director failed to comply with regulatory requirements, specifically assuring the health, safety and comfort of each child. Interviews conducted on 2/13/15 with staff members revealed that several children are being repeatedly bitten by one (1) child whom has been identified as having needs requiring special services. Review of the aforementioned child's enrollment file revealed thirty-six (36) biting incident reports between 9/23/14 and 2/6/15. Review of the center's staff handbook and parent handbook revealed the center did not have an active policy specifically regarding excessive biting.
