- (a) Request that the prospective child care staff member provide a copy of his or her driver's license or other government-issued photo identification and verify that the photograph clearly matches the prospective child care staff member;
- (b) Request that the prospective child care staff member complete and sign the:
- 1. DCC-500, Applicant Child Care Staff Member Waiver Agreement and Statement; and
- 2. DCC-501, Disclosures to Be Provided to and Signed by the Applicant Child Care Staff Member; and

General: Based on review of documentation, a caregiver hired on 3/10/21, did not have a processed child abuse/neglect check and criminal records check on file.

Findings:

General: Based on observation, a school-age child walked from the boys' restroom back to the NTI camp room, which was forty-one (41) feet in distance. He was not within sight of a caregiver or range of a voice.

General: Based on review of documentation, a caregiver hired on 6/15/20, had an evaluation on file dated 6/8/20.

Findings

General: Based on review of documentation, two (2) caregivers hired on 10/21/19 and 5/3/21, each did not have education documentation on file.

- (1) Child-care center staff:
- (b) Shall provide, prior to employment and every two (2) years thereafter:
- 1. A statement from a health professional that the individual is free of active tuberculosis; or
- 2. A copy of negative tuberculin results.

Findings:

General: Based on review of documentation, four (4) caregivers hired on 10/21/19, 5/3/21, 6/1/21, and 6/1/21, each did not have TB documentation on file.

410 - Training Not In Compliance

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation completed within the first three (3) months of employment in a child care program;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and

General: Based on review of documentation, a caregiver hired on 10/19/20, completed orientation training on 2/16/21, which was not within the first three (3) months of employment. Also, a caregiver hired on 6/15/20, last completed the Pediatric Abusive Head Trauma Training on 3/1/16.

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Based on observation, dark spots and a sticky substance was on the tile floor in the dining area of room 1-A. Dark spots and lint were on the tile floor under a table where the small refrigerator was located in the preschool room A. Also, approximately an eight (8) inch long brown circle was on a ceiling tile near the ceiling vent in room 1-A.

- (6) Medication, including refrigerated medication, shall be:
- (a) Stored in a separate and locked place, out of the reach of a child unless the medication is:
- 1. A first aid supply and is maintained in accordance with subsection (1) of this section;
- 2. Diaper cream, sunscreen, or toothpaste. Diaper cream, sunscreen, or toothpaste shall be inaccessible to a child;
- 3. An epinephrine auto-injector. A licensed child-care center shall comply with KRS 199.8951 and 311.646, including:
- a. An epinephrine auto-injector shall be inaccessible to a child;
- b. A child-care center shall have at least one (1) person onsite who has received training on the administration of an epinephrine auto-injector if the child-care center maintains an epinephrine auto-injector;
 - c. A child-care center shall seek emergency medical care for a child if an auto-injector is administered to the child; and
- d. A child-care center shall report to the child's parent and the cabinet in accordance with 922 KAR 2:090, Section 12(1)(b) if an epinephrine auto-injector is administered to a child: or
- 4. An emergency or rescue medication for a child in care, such as medication to respond to diabetic or asthmatic condition, as prescribed by the child's physician. Emergency or rescue medication shall be inaccessible to a child in care;
- (b) Kept in the original bottle; and
- (c) Properly labeled.
- (7) Medication shall not be given to a child if the medication's expiration date has passed.

Findings:

General: Based on observation, a tube of Aquaphor Healing Ointment was not labeled to indicate to whom it belonged to in a locked file cabinet in the two and three-year olds' room.

- (3) Rest time shall include adequate space specified by the child's age as follows:
- (a) For an infant
- 1. An individual non-tiered crib that meets Consumer Product Safety Commission standards established in 16 C.F.R. 1219-1220;
- 2. A firm crib mattress in good repair with a clean tight-fitted sheet that shall be changed:
- a. Weekly; or
- b. Immediately if it is soiled or wet;

Findings:

General: Based on observation, a pink sheet and a gray elephant sheet fit loosely on crib mattresses in the infants' room. A pink floral sheet and a gray elephant sheet fit loosely on crib mattresses in room 1-B.

820 - Indoor/Outdoor Equipment

922 KAR 2:120. Section 11. Toys and Furnishings.

- (2) Indoor and outdoor equipment shall:
- (a) Be clean, safe, and in good repair;
- (b) Meet the physical, developmental needs, and interests of children of different age groups;
- (c) Be free from sharp points or corners, splinters, protruding nails or bolts, loose or rusty parts, hazardous small parts, lead-based paint, poisonous material, and flaking or chalking paint; and
- (d) Be designed to guard against entrapment or situations that may cause strangulation.

Findings:

General: Based on observation, a Little Tikes Fire Truck riding toy had broken parts with sharp edges on the outdoor play area. White spots and smears were on the lid of the trash receptacle in the preschool room A. A Fisher Price Easy Fold Highchair had sticky substance on the frame of the highchair in the infants' room. A sticky substance was on the lid of a black trash receptacle in the NTI camp room.

General: Based on observation, there was no thermometer in the refrigerator compartment of the double sided refrigerator in the NTI room. A thermometer was missing an end cap and frost was inside of the thermometer in the small refrigerator in room 1-B. Therefore, the temperature could not be determined.
