General: Based on Observation, one (1) Little Tikes teeter totter was missing the support handles. An Angels tricycle was missing a foot pedal in the outdoor play area. A blue Cosco highchair did not have the safety straps on the chair in the infants' room. A metal climbing pole with four (4) round steps was detached from a large outdoor play apparatus in the outdoor play area.
