Findings: General: Upon request, a staff evaluation was not presented for (2) two staff members with the hire dates 05/25/2017 and 05/18/2009.	
350 - Health, Safety, Comfort	Not In Compliance
922 KAR 2:090. Section 10. Director Requirements and Responsibilities. (1) A director shall: (l) Assure the health, safety, and comfort of each child;	
Findings: General: Observation of the restroom located off the hallway revealed a toilet brush beside the toilet that was accessible to the children. Observation of the two and three year old restroom revealed a toilet brush sitting beside the toilet, accessible to the children.

Findings: General: Upon request, a high school diploma, GED, or Commonwealth Child Care Credential was not presented for review for the staff member with the hire date 08/1/2019.	

410 - Training

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
 - (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
 - (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on review of presented staff files, a staff member with the hire date 08/19/2019 did not complete the six (6) hours of cabinet-approved early care and education orientation training. Review of ECE TRIS report did not verify that the training hours had been completed.

- (a) Posted in writing in a conspicuous location with each age group and followed;
 - (b) Of activities that are individualized and developmentally appropriate for each child served;
 - (c) That provides experience to promote the individual child's physical, emotional, social, and intellectual growth and well-being; and
 - (d) Unless the child-care center is a before- or after-school program that operates part day or less, that offers a variety of creative activities including:
 - 1. Art or music;
 - 2. Math or numbers;
 - 3. Dramatic play;
 - 4. Stories and books;
 - 5. Science or nature;
 - 6. Block building or stacking;
 - 7. Tactile or sensory activity;
 - 8. Multi-cultural exposure;
 - 9. Indoor or outdoor play in which a child makes use of both small and large muscles;
 - 10. A balance of active and quiet play, including group and individual activity;
 - 11. An opportunity for a child to:
 - a. Have some free choice of activities;
 - b. If desired, play apart from the group at times;

Findings:

General: Upon request, a plan of activities was not presented for review in the two (2) year old classroom.

540 - Premises Requirements

922 KAR 2:120. Section 4. Premises Requirements.

- (1) The premises shall be:
- (a) Suitable for the purpose intended;
 - (b) Kept clean and in good repair;

Findings:

General: Observation of the infant (A) classroom revealed the sink faucet was loose and not secure. Observation of the restroom located off the hallway revealed a dried yellow substance on the wall and the baseboard.

580 - Floors, Walls, Ceilings

922 KAR 2:120. Section 4. Premises Requirements.

- (9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Observation of the two and three year old (A) and (B) classrooms' ceiling revealed brown stains throughout the classrooms, indicative of water damage. Observation of the Tiny Tots classroom (A) revealed a wall beside the sink that had five (5) holes and paint was chipping, exposing the dry wall. Observation of the ceiling in the Tiny Tot classroom (B) revealed a hole in the ceiling tile.

640 - Toilet Room

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

- (2) A toilet room shall:
- (a) 1. Be provided for each gender; or
 - 2. A plan shall be implemented to use the same toilet room at separate times;
 - (b) Have a supply of toilet paper; and
 - (c) Be cleaned and disinfected daily.

Findings:

General: Based on observation of the restroom located off the hallway, there was a dried yellow stain on the wall and the baseboard.

645 - Sink

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

(3) A sink shall be:

- (a) Located in or immediately adjacent to toilet rooms;**
- (b) Equipped with hot and cold running water that allows for hand washing;**
- (c) Equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit;**
- (d) Equipped with liquid soap;**
- (e) Equipped with hand-drying blower or single use disposable hand drying material;**
- (f) Equipped with an easily cleanable waste receptacle; and**
- (g) Immediately adjacent to a changing area used for infants and toddlers.**

Findings:

General: Observation of the two (2) year old classroom revealed the sink was not adjacent to the changing area. Observation of the aforementioned room revealed a door that was closed with a door knob. Continued observation revealed once a staff member changes all diapers they open the door and go to the hallway restroom where the nearest sink was located. Interview with the staff member stated they use hand sanitizer on the children after each diaper change and when all the children are changed, the staff member take all the children to the restroom to wash their hands. Observation of the Tiny Tot (B) classroom sink revealed there was no running hot water when the surveyor turned the knob to measure the water temperature.

- (b) Be placed on a surface that is:**

 - 2. Padded;**
 - 3. Free of holes, rips, tears, or other damage;**
 - 4. Nonabsorbent;**
 - 5. Easily cleaned; and**
 - 6. Free of any items not used for diaper changing.**

Findings:

General: Based on observation of the infant (B) classroom diaper changing area, there was a buildup of dust and debris under and around the changing pad.

(20) An outdoor play area shall be:

- (d) Safe from foreseeable hazard;**

- (h) Visible to staff at all times.**

Findings:

General: Observation of the playground area revealed an area where the black ground covering was exposed, creating a tripping hazard in that area.

(3) Rest time shall include adequate space specified by the child's age as follows:

- (a) For an infant:**
 - 1. An individual non-tiered crib that meets Consumer Product Safety Commission standards established in 16 C.F.R. 1219-1220;**
 - 2. A firm crib mattress in good repair with a clean tight-fitted sheet that shall be changed:**
 - a. Weekly; or**
 - b. Immediately if it is soiled or wet;**

Findings:

General: Based on observation of the one year old room, there were four (4) mattresses that were cracked and the inside material was exposed.

815 - Toys/Furniture

(1) All toys and furniture contacted by a child shall be:

- (a) Kept clean and in good repair; and**
- (b) Free of peeling, flaking, or chalking paint.**

Findings:

General: Based on observation of the infant (B) classroom, one (1) high chair was soiled with food and debris. Observation of the library center in the two (2) year old room revealed a broken book shelf; there were exposed screws and splintery wood that the children had access to.
