General: Based on observation, the surveyor found the following:

1. One (1) staff member (DOH: 7/17/17) was in the infant classroom alone with seven (7) children. The youngest child in the classroom was eleven (11) months old. The staff-to-child ratio for infants is one (1) staff to five (5) children. Therefore, the infant classroom was over the staff-to-child ratio.

2. One (1) staff member (DOH: 4/13/17) was in the preschool classroom alone with twelve (12) children. The youngest child in the classroom was two (2) years old. The staff-to-child ratio for children age two (2) and up is one (1) staff to ten (10) children. Therefore, the preschool classroom was over the staff-to-child ratio.
