<p>General: Based on Observation, the surveyor entered the facility at approximately 8:05 am. The surveyor observed three (3) staff in the infant room. One (1) staff left the room while the surveyor was getting the names of the other staff and counting the children. The surveyor obtained the name of the teacher in the one (1) year old room and counted children. The surveyor visited the two (2) year old room and counted children and obtained the names of the staff. Then the surveyor visited the three (3) to four (4) year old room, their were thirteen (13) children and the two (2) staff. The one (1) staff person was sitting in the infant room when the surveyor entered the facility. It is undetermined the amount of time the three (3) to four (4) year old class was out of ratio.</p>
