Findings:	
General: Based on observation, there were several tubes of sunscreen found in an unlocked sink cabinet in the two-year-old bathroom. The labels on the sunscreen stated to keep out of reach of children. The sunscreen was accessible to the children.

Findings:	
General: Based on review of documentation, staff hired on 07/01/08, did not have documentation on file from a health care professional that she was free of active tuberculosis.	

410 - Training

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:**
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;**
 - (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and**
 - (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.**

Findings:

General: Based on observation and review of documentation, staff hired on 07/01/08, had not completed the pediatric abusive head trauma class that is required by the cabinet. This staff person was cited for this deficiency last year. This information was verified through ECE-TRIS.

 - 2. Ventilated; and**
 - 3. Well lit, including clean light fixtures that are:**
 - a. In good repair in all areas; and**
 - b. Shielded or have shatter-proof bulbs installed; and**
 - (b) Following are protected:**
 - 1. Windows;**
 - 2. Doors;**
 - 3. Stoves;**
 - 4. Heaters;**
 - 5. Furnaces;**
 - 6. Pipes; and**
 - 7. Stairs.**

Findings:

General: Based on observation, there were no protective coverings over the overhead lights in all three bathrooms of the facility that are used by the children. It could not be determined if the light bulbs were shatter proof.

- (5) Staff shall:**
- (a) Maintain personal cleanliness;**
 - (b) Conform to hygienic practices while on duty;**
 - (c) Except as established in paragraph (d) of this subsection, wash their hands with liquid soap and running water:**
 - 1. Upon arrival at the center;**
 - 2. After toileting or assisting a child in toileting;**
 - 3. Before and after diapering each child;**
 - 4. After wiping or blowing a child's or own nose;**
 - 5. After handling animals;**
 - 6. After caring for a sick child;**
 - 7. Before and after feeding a child or eating;**
 - 8. Before dispensing medication;**
 - 9. After smoking or vaping; and**
 - 10. If possible, before administering first aid; and**
 - (d) Use hand sanitizer or hand-sanitizing wipes if liquid soap and warm running water are not available in accordance with paragraph (c) of this subsection. The staff shall wash the staff's hands as soon as practicable once liquid soap and warm running water are available.**

Findings:

General: Based on observation, the following was found:

- 1) A staff person in the infant classroom wiped a child's face and arm off after the child had spit up and the staff person did not wash her hands after she placed the child back on the floor.
- 2) The one-year-old children finished eating their breakfast and went back to their classroom without first washing their hands. The children were seen playing with balls and toys in the classroom.

 - 5. Easily cleaned; and
 - 6. Free of any items not used for diaper changing.

Findings:

General: Based on observation, the changing pads were torn in both the two-year-old classroom and the infant classroom.

General: Based on observation, a closet door knob was hanging down and not securely attached to the door in the two-year-old classroom.

General: Based on review of documentation, there was no written proof that a fire drill had been conducted for July 2020.

General: Based on observation and review of documentation, the 2019 statement of deficiencies and plan of correction issued by the cabinet was not posted for public inspection.
