<p>922 KAR 2:280. Section 3. Implementation and Enforcement.</p> <p>(1) A person who is a child care staff member prior to January 1, 2018, shall submit to and complete background checks in accordance with this administrative regulation no later than September 30, 2018.</p> <p>(2) A child care staff member hired on or after April 1, 2018, shall:</p> <p>(a) Have completed the background checks required in accordance with this administrative regulation and been found to have no disqualifying offense prior to becoming a child care staff member; or</p> <p>(b)1. Have submitted to the background checks required in accordance with this administrative regulation;</p> <p>2. Not be left unsupervised with a child in care pending the completion of the background checks in accordance with this administrative regulation; and</p> <p>3. Be dismissed or relocated from the residence if the person is found to have a disqualifying background check result.</p>	
Findings:	
<p>General: Based on observation, interview and review of documentation, the child care center failed to maintain background checks in accordance with regulatory requirements. Observation of the school age room at 12:27p.m. revealed there was a staff member with the hire date 07/03/2021 who was the sole caregiver for eight (8) children through the duration of the inspection. The age of the children range from six-years-old through ten-years-old. Interview with the staff member revealed that he/she was new. Upon request, the director did not present verification that a completed background check with an eligibility date from the National Background Check Program (NBCP) had been completed for the staff member with the hire date 07/03/2021. Review of the Kentucky Applicant Registry and Employment Screening (KARES) revealed that the staff member with the hire date 07/03/2021 was not listed as an employee at the child care center. The director did present a Child Abuse and Neglect (CAN) background check and a Criminal Records Check (CRC) for the aforementioned staff member.</p>
