General: Based on observation and interview, the childcare center director failed to assure compliance with regulatory requirements. Observation of the Pre-school room bathroom revealed a toilet plunger that was unsanitary and accessible to the children. Interview with the staff in charge revealed the plunger was there and needed to be removed.

General: Based on interview and review of documentation, the childcare center failed to maintain employee records in accordance with regulatory requirements. Upon review of records and interview a copy of a high school diploma, GED or a commonwealth child care credential for an employee with the hire date of 11/19/19 was not presented for review.

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings

General: Based on interview and review of documentation, the child care center failed to maintain employee records in accordance with regulatory requirements. Upon request, the staff in charge did not present verification that two (2) staff members with hire dates of 11/13/13 and 10/01/18 had completed the required fifteen (15) annual hours of cabinet approved early care and education training. Also, upon request the staff in charge did not present verification that one (1) staff members with hire date of and 11/13/13 had completed the required one-half hours of pediatric abusive head trauma (PAHT) training. Review of an ECE-TRIS report could not verify that the training had been completed.
