# Findings:

Preschool Room: Based on observation, a caregiver and ten (10) preschool children were in the preschool classroom with the door closed. The room was extremely dark. The caregiver was in a chair and ten (10) children were on nap mats. This caregiver could not devote full time attention to each child due to the darkness in the room on 07/26/12. Infant: Based on observation and interview, a caregiver, hire date 05/01/12, left a child in a crib in the infants' room while she took a second infant to the dining room. The caregiver placed the infant in a bouncy seat in the dining room and returned to the infant' room for the infant left in the crib.

Dining Room: Based on observation and interview, three (3) children, ages one (1) year to six (6) years old, were not supervised in the dining room at 1:50 p.m. on 07/26/12. The caregiver in the infants' room stated she supervised the two (2) infants and the three (3) children in the dining room.

# 1) CRC Not In Compliance

#### Findings:

General: Based on review of documentation, observation and interview, a caregiver, hire date 05/01/12, supervised two (2) infants in the infant room at 1:50 p.m. on 07/26/12. The caregiver moved the infants to the dining room and supervised a total of five (5) children, ages six (6) months old to six (6) years, until another caregiver arrived at 2:00 p.m. This caregiver, hired 05/1/12, did not have a completed criminal records check on file.

General: Based on a review of documentation and interview, a caregiver, hire date 05/01/12, did not have education information on file at the center on 07/26/12.
