General: Based on review of documentation and interview, this regulatory requirement was not met. A review of staff files during the inspection found one staff person that did not have the date of employment listed in their file. The staff person in charge thought for a minute and then verbally identified the date 2/7/22, as the hire date. However, the date of hire was not maintained in the personnel file.
