

General: Based on Review of Documentation and interview, staff hired 4/20/15, did not complete orientation training. Staff hired 3/27/12, 3/27/96 and 3/27/13, completed three (3) hours of training and staff hired 3/28/10 and 4/20/15, had not completed any training hours.
