#### **Inspection Summary**

A statement of Deficiency (SOD) and a Plan of Correction (POC) was issued to the Facility at the completion of the inspection. The SOD documented identified deficiencies in the following regulation categories):

- Administrative records
- Recordkeeping for staff and children;
- Suitability for employment (criminal background checks and alcohol and drug testing)
- Staff qualifications and responsibility and professional development
- Environmental (Indoor and outdoor environments)
- Health and safety

There were no deficiencies cited during this inspection that presented imminent danger to the health, safety and welfare of children, adults, or the general public.

Consistent with the plan of correction, the facility corrected all areas of non-compliance by 9/19/2019.
